We advocate for responsible management of those resources and lead discussions around driving practical policy change. Our primary focus is the agriculture drainage policy, working with government and the Water Security Agency (WSA) to create a policy that is workable, easy to understand and that benefits farmers and the environment.

Drainage is a critical business risk management tool for Saskatchewan agriculture producers. Drainage increases farm efficiency and productivity. Properly designed water management systems have many agronomic, environmental and economic benefits:
